

**NOTICE OF PRESENTATION

TAKE NOTICE that the present Application for Interim and Final Orders in connection with a Proposed Arrangement will be presented for adjudication of the Final Order sought therein to the Superior Court of Québec, sitting in the Commercial Division, in and for the District of Québec at the Québec Courthouse located at 300 Jean Lesage Boulevard, Québec, Québec, G1K 8K6, on **August 9, 2018 at 2:00 p.m. in room 3.07.**

TAKE FURTHER NOTICE that, if you do not file an answer (notice of appearance) within the above-mentioned time limits, you will not be entitled to contest the Application for a Final Order or make representations before the Court, and the Applicant may be granted a judgment without further notice or extension.

If you wish to make representations or contest the issuance by the Court of the Final Order, it is important that you take action within the time limits indicated, either by retaining the services of an attorney who will represent you and act in your name, or by doing so yourselves.
